

Responsible Souvenir Guide – Uganda & Rwanda

Shopping for crafts and gifts is one of the joys of travel, but not every item sold in markets or along roadsides is ethical, legal, or environmentally friendly. Some may come from endangered wildlife, rare plants, or protected cultural artefacts, while others may involve child labour or illegal substances. Purchasing such items can harm local communities, fuel illegal trade, and lead to serious consequences such as fines, confiscation, or prosecution under national or international law.

This guide draws on the Uganda National Red List of Threatened Species (2016), Rwanda's Biodiversity Policy, the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), and relevant national laws including the Uganda Wildlife Act (2019) and the Rwanda Environment and Wildlife Laws (2018–2020) to help visitors make responsible souvenir choices. By following these guidelines, you help protect wildlife, preserve cultural heritage, and support local artisans in both Uganda and Rwanda.

Discouraged Souvenirs in Uganda and Rwanda

Ivory or Rhino Horn Products	Hand-carved soapstone, recycled metal, or wooden crafts
Big Cat Skins or Crocodile Leather	Locally made fabrics or ethically sourced livestock

Pangolin Scales / Bushmeat	Banana fibre, papyrus, sisal, or clay crafts
Rare or Wild Plants	Seeds or potted plants from certified nurseries
Cultural Artefacts / Human	Handmade replicas by local artisan cooperatives

Child Labour Products	Fair-trade crafts from adult artisan groups
Illegal Substances	Herbal teas, natural oils, or certified local products
Counterfeit or Imported Goods	Authentic crafts made by community cooperatives

Other Recommended Ethical Souvenirs from Uganda and Rwanda

- 1. Handwoven baskets and mats made from banana fibres, papyrus, or raffia
- 2. Barkcloth products such as wallets, purses, and artwork (UNESCO-recognized)
- 3. Bead jewellery made from recycled paper, seeds, or glass
- 4. Hand-carved wooden crafts from sustainably sourced or reclaimed wood
- 5. Colourful textiles and clothing made from *kitenge* and *imigongo* patterns
- 6. Locally produced coffee, tea, cocoa, and honey from smallholder farmers
- 7. Traditional music, literature, and visual art that celebrate local culture
